The responsibilities of the quarterly committees are to serve at the social functions of the church, such as receptions, funeral dinners, quarterly Sunday dinners and other social activities that may be scheduled. The quarterly chairman and co-chairman will contact committee members when help is needed.

Committees shall clean and check the kitchen at the beginning of each quarter.

The church will not host bridal or baby showers, but any individual or group who wishes to host may use the church facilities for this purpose.

Any event may be scheduled on the church calendar and sponsored by individuals or groups as long as the event meets the guidelines of the church constitution on the use of the church. The kitchen committees will be available to help with the events.

Always check supplies in the kitchen before an event. Always clean and put away everything after each event.

First Baptist Church has a charge account at J's Foods, Shopko and Dollar General, but **please check with the hostess before purchasing any food or supplies.** If you purchase elsewhere, such as out of town, please give the paid receipt to the treasurer so you may be reimbursed. Turn in any bills immediately.

Please inform the custodian or the church office of any upcoming event so the fellowship hall may be set up as required. There are several storage containers of decorations in the hall cabinet. Please check the inventory of decorations before purchasing more.

Team members should try to bring a main dish plus an extra dish to the quarterly dinner during their quarter of service.
